ARTICLES OF INCORPORATION
OF
PALOS VERDES MONACO HOMEOWNERS ASSOCIATION

I

The name of this corporation shall be PALOS VERDES MONACO HOMEOWNERS ASSOCIATION.

II

The purposes for which this corporation is formed are:

1. To study and propose solutions to problems involving the administration of law enforcement, fire, traffic, safety, sanitation and utility services which might concern the general welfare of the residents of Palos Verdes Monaco.
2. To consider the effects of zoning and the plans for the general development of the Palos Verdes Peninsula and, more specifically, to the acres immediately surrounding Palos Verdes Monaco.
3. To provide representation before governmental authorities and bodies to express the feelings and desires of the residents of Palos Verdes Monaco.
4. To promote the general improvement of Palos Verdes Monaco and consider and make recommendations on other matters which might concern the general welfare of the residents of Palos Verdes Monaco.

III

This corporation is organized pursuant to the General Nonprofit Corporation Law of the State of California. This corporation does not contemplate pecuniary gain, or profit to the members thereof and it is organized for nonprofit purposes.

IV

The county in this State where the principal office for the transaction of the business of this corporation is located in Los Angeles County.

V

The general management of the affairs of this corporation shall be under the control, supervision and direction of the board of directors. The names and addresses of the persons who are to act in the capacity of directors until the selection of their successors are:

different classes of membership, if any, the property, voting and other rights and privileges of members, and their liability to dues and assessments and the method of collection thereof, shall be as set forth in the bylaws.

VII

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private individual. Upon the dissolution or winding up of the corporation its assets, remaining after payment, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.

If this corporation holds any assets in trust, or the corporation is formed for charitable purposes, such assets shall be disposed of in such manner as may be directed by decree of the superior court of the county in which the corporation has its principal office, upon petition therefore by the Attorney General or by any person concerned in the liquidation, in a proceeding to which the Attorney General is a party.

VIII

The name of the unincorporated association which is being incorporated is PALOS VERDES MONACO HOMEOWNERS ASSOCIATION. IN WITNESS WHEREOF, the undersigned, being the president and the secretary, respectively, of PALOS VERDES MONACO HOMEOWNERS ASSOCIATION, the unincorporated association which is being incorporated hereby, have executed these Articles of Incorporation this 30 day of May, 1975.

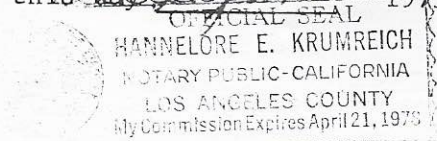
